In case I "freeze", I offer the following precedence for inviting the rabbi and leaders from any faith community to participate in prison ministry:

For many years, former EMP ministry the Perinton Lay/Clergy Council conducted an interfaith Thanksgiving service. Participants included representatives of a variety of faiths, including Islam, Hindu, Jewish, Native American, etc. One of my cherished memories of the event is the Iman offering his support and assistance to David Abrahams who was studying to be a Rabbi then. While one pastor strongly objected, other member churches were supportive.

Rabbi David Abrahams of Congregation Etz Chaim is part of the Perinton Clergy Council which established and runs the Fairport Good Neighbor Fund. He served twice as Treasurer. His congregation also participated in the Interfaith service.

Our ministries of both PEM and EMP welcome volunteers from and serve people of all faiths or no faith. For example, we've built a Habitat home for a Muslim family and gave them a Quran rather than Bible at the dedication ceremony.

I support amending the wording of the PMUNY website to reflect enriching the faith of all prisoners, not just Christian prisoners.
